DAILY net rates per room, in B&B (American buffet breakfast):
€ 138,00 for the double room for single use;
€ 158,00 for the double room;

Within April 13th, 2015

- Statutarni město KARLOVY VARY will send 10% deposit not refundable through bank money transfer, sending the copy of the bank transfer as proof of payment, or charged on a credit card.

Within May 12th, 2015

- Statutarni město KARLOVY VARY can reduce the number of rooms not more than 20% of the total booked, without any penalty; in case the cancellation exceeds 20% of the total rooms, it will be charged 100% per extra room cancelled;
- Statutarni město KARLOVY VARY will send 40% deposit not refundable through bank money transfer, sending the copy of the bank transfer as proof of payment, or charged on a credit card.

Within June 2nd, 2015

- Statutarni město KARLOVY VARY can reduce the number of rooms not more than 10% of the total booked, without any penalty; in case the cancellation exceeds 10% of the total rooms, it will be charged 1 night per room cancelled;
- Settlement through bank money transfer, sending the copy of the bank transfer as proof of payment, or charged on a credit card;
- After this date, each cancellation is subject to 100% penalty charge.
